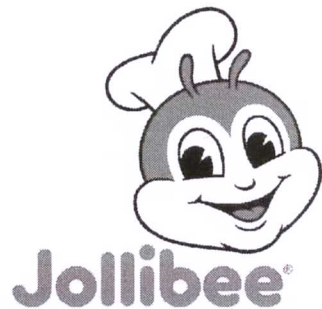

JFC to increase investment in Buyer of Tim Ho Wan Franchisee

**Background/Description of the Disclosure**

Further to its May 8, 2018 disclosure, JFC disclosed today that the fund size of Titan Dining LP ("Titan"), of which Jollibee Worldwide Pte. Ltd. (JWPL) is an investor, will be increased from SGD100Mn to SGD200Mn, and that in connection therewith, JWPL will increase its capital commitment to Titan from SGD45Mn to SGD120Mn. As a result, JFC's investment will constitute 60% of the fund. The increase in fund size and additional capital commitment of JWPL are in furtherance of certain strategic projects currently being undertaken by Titan, consistent with its mandate to invest in the food service sector and grow strong Asia Pacific food service brands.


