Jollibee Foods Corporation (JFC) announced that its Board of Directors approved today, April 6, 2016, a cash dividend of Php0.86 per share of common stock for all shareholders of record as of April 21, 2016 (ex-dividend date of April 18, 2016). This cash dividend is 7.5% higher than that declared on April 7, 2015. Payment date is on May 6, 2016.

Jollibee Foods Corporation has a policy of declaring regular cash dividends representing 33% of estimated earnings per share for the year. These cash dividends are declared and paid twice each year; the first in May and the second in December. The first usually comprises 45% of the annual cash dividend and the second 55%. JFC also pays special cash dividends if it has surplus cash; that is, if it does not have new business acquisition in a year.
